Those of you who attended the annual meeting heard me announce that, in compliance with the Bishop's directive, we will at some point have an evacuation drill during our Sunday morning worship. I mentioned then that I think all of us have taken part in fire drills and many of us also remember air raid drills. I firmly believe that the possibility of fire is greater than other dangers, but I want to share the Bishop's letter with you, as she reminds us that other dangers do exist. In any event, the purpose of drills is to prevent panic in a time of great stress. If an evacuation were ever necessary for our safety, the process will be less stressful because we have rehearsed it and know what to do. I look forward to working with our safety committee in the weeks ahead.

Dear Companions in Ministry,

A year ago, on October 27, the Tree of Life Synagogue was irrevocably changed by the horror of a mass shooting as members arrived for study, worship, and to enjoy community together. The impact was felt immediately by grieving family and friends, synagogue members, and the city of Pittsburgh. Many people in our nation were shocked by the horror of another mass shooting in a house of worship. Despite grief, horror, and shock, this type of shooting has become part of our common life.

Because of this distressing reality, it is important to take precautions for church safety. The clergy and lay leaders of each congregation in our diocese must **prepare and implement a plan for church safety and evacuation by Lent I (March 1, 2020)**. This written plan will contain the three steps listed below and must be emailed to Jim Caputo, Diocesan Property and Risk Manager, (jcaputo@dioceseofnewark.org) by or **before March 1.** In that email, you will confirm that these three steps have been taken or provide the date(s) planned for their completion:

Contact your local police department and ask for a police officer to visit your church to walk through the building and discuss safety recommendations.

Train all ushers to be aware of and alert to their surroundings, including assigning one usher to check the church parking lot or street parking periodically during worship and church events.

Plan an evacuation drill for the church. Once planned, communicate the drill dates to the congregation for a minimum of three weeks before the drill. Drills should take place annually and during regular Sunday worship. (note: Drills may take place after March 1, but the date for the drill will need to be reported with your plan.)

You do not and should not make this kind of plan without help. There are resources readily available. Police departments across the nation have increased their attention to the special safety needs of worshiping communities. They have a keen awareness of the challenges churches face when planning for safety. Several of the diocesan clergy and I have benefitted from the advice, experience, and expertise of police to help parish leaders determine best steps for church safety.

Additionally, Jim Caputo has begun working with parishes as they prepare and implement safety and evacuation plans. As Jim frequently says, "Our goal is not to scare people, but to keep them safe." While Jim will not create a plan for you, he is available to advise and support your process of determining what will work best in your church.

At this year's Clergy Day, I talked about the need for parishes to develop safety and evacuation plans. It is important that clergy, wardens, vestry, and key lay leaders be involved in the process of developing a plan to heighten awareness and promote church safety. It will take the efforts of a full team to develop a plan that works in your parish.

The sad truth is violent acts will continue. So, I will continue to hope, pray, and advocate for these acts to stop. Until then it is wise for us to be aware and prepared.

Morris County Municipal Utilities Authority E-Waste - Computers, TVs, etc.

Category: Hazardous

- Activity Type: Recycling
- **Management Issues:** CRTs in monitors contain lead and computers and electronics contain other heavy and precious metals that can be extracted for proper management during a process called

"demanufacturing." Materials that are recovered for value are marketed as such and the hazardous wastes are need to be disposed.

- Handling Tips: Contact any drop off location prior to delivering electronics as acceptance policies may change from time to time.
- **Regulations:** The Electronic Waste Management Act requires all original equipment manufacturers to establish and finance a collection, transportation and recycling system for the recovery of computers, laptops, televisions and monitors, desktop printers and fax machines. It also establishes a disposal ban on these electronic devices. As of 2018 E-waste recycling is not mandated for any item accept the abovementioned items. As such non-covered electronics and accessories not listed above are permitted to be disposed of in the garbage.
- Mandated Recycling: If generated in Morris County, this material is required to be separated at the source by the waste generator and ultimately recycled. The material may not be mixed with garbage and additionally, materials mandated to be source separated and recycled cannot be separated from disposables by anyone or any facility but the generator at the site where the recyclables and disposables are generated. A materials recovery facility may not perform separation of recyclables from disposables on behalf of the waste generator.
- **Special Handling:** This material requires special handling other than traditional disposal and recycling facilities.
